TRANSLATION

Fee Exemption for female students from all levels of Education

Government Resolution:

To date, education from standard 1 to 11 is free. To promote girls' education, the government has decided to exempt girls' students from tuition fees from this year, 1985-86. It is hereby declared that the female students will be exempted from tuition fees from (1) Standard 12th (2) At UG Level in Arts, Science, Law, Commerce, and UG Courses in Education (3) Engineering, Ayurveda, Homeopathy, Dentistry, Nursing, MBBS, Pharmacy, Diploma & Degree Courses of Agriculture and Veterinary and (4) The female students who are pursuing UG and PG in universities will be exempted from tuition fees from the year 1985-86.

2. It is also declared that female students, as mentioned above if they are studying in non-government higher education institutions or self-finance institutions, such institutions will be paid an equal amount of the fees of female students.

3. Non-government, i.e., self-finance institutions, will pay the fees of female students the same amount. The system of the Education Department for the payment will be as follows:

1. The non-government schools must inform the strength of female students with the names of standard 12th and the income of tuition fees of those female students to the office of the District Education Officer by the end of August. The amount of tuition fees will be paid to the non-government schools by the office of the District Education officer after verifying the required details by the end of September. For the even semester, the above process must be done in the month of January and February respectively.



2. The non-government Arts, Science, Law, Commerce, and Education institutions must send the strength of the female students with their names and the income of tuition fees of the female students of the college to the office of Director of Higher Education, Gandhinagar by the end of the August. After the verification, the amount of the tuition fees of the female students will be paid to the non-government institutions by the office of the Director of Higher Education till the end of September. For the even semester, the above process must be done in the months of January and February.

3. Besides this, for polytechnic and engineering colleges the same process which is mentioned in the para.2 must be followed and the office of the Director of Technical Education will have to pay the tuition fees of the female students to the non-government polytechnic and engineering colleges.

4. For medical, paramedical, and Agriculture-related courses, the above-mentioned process must be followed. The Health & Family Welfare Department and Agriculture and Rural Department will have to pay the tuition fees of the female students to the non-government institutions for medical, paramedical, and Agriculture-related courses.

5. The Education Department will have to borrow the expenditure incurred under 277 Education. For the year 1985-86, the expenditure of this scheme will be derived from the provision made for this purpose.

6. These orders will be issued with the consent of noting of the Finance Department dated 04/07/85 and with the consultation and concurrence of the notes of Health and Family Welfare and Agriculture Rural Development dated; 11/02/85 and 28/02/85 respectively on the file of the same number of the department.
